## **Waiver of Liability, Assumption of Risk, and Indemnity**

### **Agreement**

In consideration of being permitted to participate in the Grapple Fest event at Elite Martial Arts, the undersigned agrees to the following:

**1. Acknowledgment of Risks:**

I fully understand that participation in martial arts, grappling, and related activities may involve strenuous physical exertion and carries the risk of bodily injury, including, but not limited to, fractures, dislocations, concussions, sprains, cuts, bruises, and in rare cases, paralysis or death. I knowingly and voluntarily assume all such risks associated with my child's participation, whether such risks arise from the negligence of Elite Martial Arts, its employees, agents, or other participants, or from other causes.

**2. Medical Fitness to Participate:**

I hereby declare that my child is in good health and physically fit to participate in the Grapple Fest event. I acknowledge that my child has no medical condition or impairment that could affect their safe participation. I further agree to notify Elite Martial Arts immediately if any change in my child's medical condition occurs before or during the event that may affect their ability to safely participate.

**3. Release and Waiver of Liability:**

I, for myself, my child, and our respective heirs, assigns, personal representatives, and next of kin, hereby release, discharge, and hold harmless Elite Martial Arts, its owners, instructors, employees, volunteers, agents, and other participants from any and all claims, actions, losses, damages, or liabilities of any kind arising out of my child's participation in the event, including injury, illness, disability, or death, whether caused by the negligence of Elite Martial Arts or otherwise.

4. **Assumption of Responsibility for Personal Property:**

I understand that Elite Martial Arts is not responsible for any personal belongings lost, damaged, or stolen during the event. I agree to assume full responsibility for any personal items brought to the event by my child.

5. **Medical Treatment Authorization:**

In the event of an injury or medical emergency, I authorize Elite Martial Arts staff to obtain medical care for my child, including emergency medical transportation and treatment, as deemed necessary. I understand that I am financially responsible for any medical expenses incurred as a result of my child's participation in the event.

6. **Compliance with Rules and Regulations:**

I agree that my child will comply with all instructions, safety rules, and regulations set forth by Elite Martial Arts during the Grapple Fest event. I acknowledge that failure to comply may result in the removal of my child from the event, and I agree that no refunds will be given in such circumstances.

7. **Photo/Video Release:**

I understand that photographs and videos may be taken during the event, and I give my consent for my child to be photographed and/or videotaped for promotional purposes. These images may be used in Elite Martial Arts' marketing materials, website, or social media without compensation.

8. **Indemnification Clause:**

I agree to indemnify, defend, and hold harmless Elite Martial Arts, its owners, instructors, employees, volunteers, agents, and other participants from any claims, actions, damages, costs, or expenses (including attorney's fees) arising out of my child's participation in the event, including claims brought by third parties.
